Version 1.0

- AR 30-22, The Army Food Program, dated 30 Aug 2002
- DA Pam 30-22, Operating Procedures for the Army Food Program, dated 30 Aug 2002

Version 2.0

- Major revision of AR 30-22, dated 10 May 2005
- Major revision of DA Pam 30-22, dated 6 Feb 2007



Planned Publication Process

- Rapid action revisions (**25** pages or less)
 - Prioritize changes
 - Publish on Army Publishing website:
www.apd.army.mil
- “Clean text” changes/Edition date and Summary of Changes
- Prepare next Rapid Action Revision



Actual Publication Process

- G4 pubs coordinator directed change in process
- Major Revisions (again!)

Version 3.0

- AR 30-22
 - Initial staffing: 12 Jan 10 to 12 Feb 10 COMPLETE!
 - Final staffing: 10 Apr 10 to 10 May 10 COMPLETE!
- DA Pam 30-22
 - Initial staffing: 23 Mar 10 to 23 April 10 COMPLETE!
 - Final staffing: 29 May 10 to 29 Jun 10 ON-GOING

Version 3.0 (Cont'd)

- AR 30-22
 - Next step: OTJAG review and authentication
- DA Pam 30-22
 - Next step: Update figures and authentication
- Anticipated publication in 1st Quarter FY11



Overview of changes to 30-22

- Incorporation of Directed Meals and Lodging (MTSS) guidance for institutional training
- TISA to become Subsistence Supply Management Office
- Increase cash allowed on hand in DFAC to \$1500
- ROTC guidance clarification
- Expanded common service reimbursement:
 - RCs of other services



Overview of changes to 30-22

- Incorporate revised AR 735-5 guidance
 - ROS becomes Financial Liability Investigation
 - DA Form 4697 becomes DD Form 200, Financial Liability Investigation of Property Loss
 - Thresholds remain same (\$500 and \$4000)



Overview of changes to 30-22

- Updated CONOPS guidance
 - Current policy in para 3-44j states that appropriated fund food service assets cannot be used for social functions
 - AOR request
 - Update CONOPS guidance to authorize the following special events
 - VIP or distinguished visitor visits
 - Semi-annual unit moral sustaining events
 - Monthly promotion and birthday events
 - Transfer of authority events



Field Manual Revisions

- FM Revisions → New Numbering
- FM 10-23 → ATTP 4-41
 - Army Field Feeding and Class I Operations
- FM 10-23-2 → GTSM 4-41.11
 - Dining Facility Operations
- FM 10-23-2 → GTSM 4-41.12
 - Food Program Operations



Revision of FM 10-23 and 10-23-2

- FM 10-23 (ATTP 4-41) provides tactics, techniques, and procedures for Army field feeding operations.
- FM 10-23-2 (GTSM 4-41.11) provides procedures on dining facility operations(
- FM 10-23-2 (GSTM 4-41.12) provides procedures on installatoin food program operations
- Will mirror 30-22 (as much as possible)
