# **Becoming Approved Source Suppliers**

Suppliers proposing to bid on Armed Forces contracts and whose establishments are not approved as sources of supply must submit written requests for audits signed by management through either local or central purchasing agencies.





# **Becoming Approved Source Suppliers**

Initial Sanitation Audit request

- Supplier write a letter requesting initial sanitation audit
  - owner (or authorized representative) must be signatory

 letter addressed to purchasing or contracting agency conducting business

- Minimum content requirements of letter

• Full name, street address, city, state, zip code, country of *processing facility*. (include mailing address if different)

- Facility point of contact (name, phone, fax, email)
- Normal processing facility operating hours
- Specific product list furnished (such as bread, rolls, or biscuit)

 Caterers – where prepared, military installations to be served and whether contracted

Distributor / Broker – operating in CONUS - exempt





## **Appendix B- Initial Audit Request**

#### APPENDIX B

#### INITIAL SANITATION AUDIT REQUESTS FOR THE UNITED STATES, CANADA, MEXICO, CENTRAL AMERICA, SOUTH AMERICA, THE CARIBBEAN, AND THE PACIFIC REGION

1. The supplier must write a letter (preferably on letterhead stationery) requesting an initial sanitation audit. The owner or an authorized representative of the establishment processing the product(s) must sign the letter. The supplier must address the letter to the purchasing or contracting agency he/she wishes to conduct business with. The request must contain, as a minimum, the following information:

a. The full name of the processing facility, street address (or geographical location), city, state, zip code, and county or country where the plant is located. If different, include the mailing address.

b. The name, title, telephone and fax numbers, and e-mail address of the person to contact at the facility, and the normal operating hours.

c. A list of the specific products to be furnished (such as bread, rolls, or biscuits).

d. A list of the federal, state, and local regulatory agencies who currently inspect the facility. If they have a federal or state establishment number, please provide the number as well.

e. If the vendor is a distributor or broker of finished products from other approved sources and acts within the geographic limits of CONUS, Alaska, or Puerto Rico, then the vendor is exempt from listing in this Directory unless the vendor stores Government-owned foods.

f. If the vendor is a caterer, indicate where the vendor prepares the food, which military installations the vendor will serve, and if the meals will be contracted.

2. The purchasing or contracting agency should review the request and determine if the supplier is eligible. If the agency wishes to purchase the firm's products, the agency must write a cover memorandum and enclose the supplier's request. The memorandum must include the following agency information: a correct mailing address, a point of contact, telephone and fax numbers, and an e-mail address. The agency should submit the audit request at least 6 weeks before the results are due to:


